- ▶ Update information in the Oases database in accordance with the field of responsibility;
- ▶ Create Engineering Orders;
- ▶ Participate in developing, managing and controlling the Aircraft Maintenance Program for each aircraft type when any Airworthiness Directive affecting AMP is issued;
- ▶ Monitor OEM/Vendor Service Bulletins and required actions if necessary;
- ▶ Monitor aircraft status in respect of RILs and OEBs, evaluate and perform required actions if necessary;
- ▶ Modify data in order to manage and control updated mass, weight and balance statement, which reflects the current status of the aircraft;
- ▶ Prepare and gain approval of necessary modifications, STCs.

- ▶ Airline or MRO industry experience in continuing airworthiness or maintenance;
- ▶ Knowledge of EASA rules and regulations;
